

# APPA Institutional Membership Application

Membership categories are based on your institution type. Please read the descriptions carefully to ensure that you choose the appropriate membership category. The APPA membership year runs from April 1st through March 31st.

### Institutional

Institutional membership is open to:

- All colleges and universities with their own facilities department and administrator.
- Higher education system offices, K-12, and International schools.
- Libraries and Museums

One individual is named as the Institutional Representative and is the principal contact between APPA and the institution. Other facilities department staff can join as Associate members. An unlimited number of Associates are included in the cost of dues.

### **Dues**

Dues for colleges and universities located within the U.S. and Canada are based on an institution's full-time equivalent student enrollment and gross institutional expenditures (see matrix on next page.)

Additional Associates may be added at no cost to the institution.

See the next page for dues requirements of other eligible institutions, to include those outside of the U.S. and Canada, K-12 schools, system offices, libraries, and museums.

### Additional Membership Categories:

## K-12 School, School District Membership, Libraries, and Museums:

Non-degree granting institutions of learning that accommodate either a facilities or physical plant department within its internal operations are eligible to join for a flat-fee of \$600. This fee covers a primary contact and unlimited associate members for the institution.

### System Office Membership

A college or university system that employs a facilities officer who consults or advises other facilities management efforts at two or more institutions operating under the college or university system may join for \$600. The institutions in the system must meet criteria detailed in the APPA bylaws.

### International Membership

Higher education institutions outside of the U.S. and Canada are eligible to join for \$410 U.S. This fee covers a primary contact and unlimited associate members for the institution.

### Regional Membership

In addition to APPA membership, it is strongly encouraged that you also join your local region using this application. Regional dues and benefits may vary. See below for regional dues schedule.
